### HEREBY AFFIRM THAT:

- 1. I make this affidavit in good faith, to the best of my knowledge and belief
- 2. I am a man of God and a pater familias and recognise his authority over all laws on the earth.
- 3. I invoke the power and authority of Jesus Christ over this matter.
- 4. I am a local resident of the Northern Territory and have lived here for over 50 years.
- 5. I have worked in many industries, and have run several businesses in emergency management, safety training, health and fitness, design and engineering of fire safety systems and have volunteered my whole life for many sporting organisations, NT Bushfires Council, Red Cross, and many years for NT Emergency Services.
- 6. I hold many qualifications in Occupational Health & Safety and Emergency Management.
- I have been advocating for human rights specifically with remote community tribal people
  of this country for over 15 years, and formally became a Human Rights Advocate,
  Observer and Defender 2 years ago.
- 8. I have been officially appointed by 14 sovereign tribal nations as Human Rights Ambassador [Annex A]
- I am the Plaintiff in a Form 37A Notice of Appeal appealing the extension of the State of Emergency in the Northern Territory, and personally suing Natasha Fyles for damages.
- I was appointed to the office of Ambassador to the sovereign tribal nation of Majagi on May 22<sup>nd</sup> 2022 after the Private Member's Association TIBNLA was formed [please refer Annex. B]
- 11. I tabled information onto the public record on 7<sup>th</sup> June 2022 which included the following information:
  - 3 Apparent Fraud and Criminal Actions of the NT Body Politic and NT Justice System in the fraudulent appropriation of, and unlawful use of, sacred emblems.

I have been given evidence of the apparent fraud and criminal actions of the NT Body Politic and NT Justice System in the fraudulent appropriation of, theft and

unlawful use of, sacred emblems, objects, plants, animals etc many of which belong to the Larrakia, Brinkin, Tiwi and other tribes, by way of trademarking the NT Coat of Arms, resulting in desecration of such items, and breaches of their collective human rights.

....a submission [was] made to Mr Michael Schwager, Director General of IP Australia by representatives of the Larrakia, Brinkin and Tiwi tibes which invokes Humanitarian Law / Customary Law / Tribal Lore of the Marratia and Koolpinyah, and instructs him to cancel Australian Trademark No. 90001645 – namely the NT Coat of Arms, which the Local Court sits under.

- 12. This information was subsequently filed with the World Intellectual Property Organisation [WIPO] on 15<sup>th</sup> of June 2022 who accepted it on 16<sup>th</sup> June 2022. An application for mediation was made on 3<sup>rd</sup> July 2022 and served on the other party (IP Australia) [please refer Annex. C]
- 13. TIBNLA proclaimed their independence on 15<sup>th</sup> July 2022 [please refer Annex. D], which was put on public record on 18<sup>th</sup> July via the NT News [please refer Annex. E] and Buy Search Sell classifieds.
- 14. TIBNLA took ownership of the "NT Coat of Arms" as at 19<sup>th</sup> November 2021 (when all implied permission of their tribal symbols [indigenous knowledge] was revoked by legal notice) to protect further desecration of theirs and other tribe's sacred things.
- 15. TIBNLA registered ownership of the "NT Coat of Arms" to the land mass Australia through the Universal Postal Union on 30<sup>th</sup> July 2022 by way of Registered Mail with Australia Post [please refer Annex. F].
- TIBNLA trademarked the "NT Coat of Arms" design via their Patent & Trademark Office on 30<sup>th</sup> July 2022 [please refer Annex. G].
- 17. TIBNLA have made their claim for reparation damages, fees for usage and penalties by issuing Invoice No. MTT00426 to the NORTHERN TERRITORY OF AUSTRALIA on 30<sup>th</sup> July 2022 [please refer Annex, H].

- Representing Majagi to any and all Belligerent Occupiers\* of our states / estates / lands [the
  quasi UNITED STATES, NORTHERN TERRITORY GOVERNMENT, AUSTRALIAN GOVERNMENT
  and the quasi NORTHERN LAND COUNCIL] and any other entity that is connected to them
  such as qango's inter alia as well as permanent missions to multilateral organizations.
- Representing Majagi to private member's associations to negotiate treaties, contracts, agreements, local and international trade.
- Protecting Majagi's tribal people and national interests, within the limits permitted by tribal law, which is first in time, best at law for the land known as Terra Australis, and International Laws that align with this.
- Negotiating with, and promoting friendly relations with, our Belligerent Occupiers, and developing our economic, cultural and scientific relations.
- Investigating and reporting accurately on developments of Belligerent Occupiers of our lands, which are likely to influence the formulation of Majagi's policies.
- Negotiating agreements on various national issues with the authorities of the Belligerent Occupiers of our lands.

Your actions shall be solely decided by you and you will not in any form be considered as employee or partner in any matter of the Belligerent Occupiers of our lands. It is a matter of esteem pride to have you in force as an Ambassador of the nation of Majagi.

As an official envoy, we expect faithfulness and honesty from you. We are very confident in your ability to carry out your processes in the most official manner taking care of the interests of all stakeholders.

As an Ambassador, you are subject to the Vienna Convention on Diplomatic Relations of 1961, so far as it aligns with our tribal law.






